INVITATION FOR PREQUALIFICATION FOR COMPLETION OF CONSTRUCTION WORKS FOR KABUYANDA EARTH DAM IN ISINGIRO DISTRICT

- 1. The Republic of Uganda has received financing from the World Bank toward the cost of the Irrigation for Climate Resilience project (ICRP) and intends to apply part of the proceeds toward payments under the contract for Completion of Construction works for Kabuyanda Earth Dam in Isingiro District.
- 2. The Ministry of Water and Environment intends to prequalify contractors for Completion of Construction Works for Kabuvanda Earth Dam in Isingiro District. The scope of works comprises of construction of a 38.5m high earth dam, reinforced concrete intake and spillway works and access roads. It is expected that the Request for Bids will be made in August, 2025.
- 3. Prequalification will be conducted through the procedures as specified in the World Bank's Procurement Regulations for IPF Borrowers Procurement in Investment Projects Financing" July 2016, revised November 2017, July 2018 and 6. The address referred to above is: November 2020 ("Procurement Regulations"), and is open to all eligible Applicants as defined in the Procurement Regulations.
